ServSafe Person-in-Charge (PIC) ONLINE Ohio Food Handler Course

I'm very excited to offer you one of, if not the only, ONLINE Ohio approved PIC course. I worked closely with the Ohio Department of Health (ODH) to create and achieve approval for this program. This is the simplest way to earn your credential. Online. At home. At one of the regularly scheduled session or at time you choose. Most efficient course content.

Here are the answers to what I hope are most of your questions:

When are the scheduled "live" online PIC classes offered?

- Online Classes are offered on Monday afternoon or evening. These tend to be less busy days for restaurants and caterers.
- I'm happy to arrange a custom time for you or your group if needed.

Is PIC/Food Handler the same as Food Manager?

- NO. This is the 3 hour/ Level 1 Food Handler Course which earns you a certificate.
- It is NOT the 1 to 2 day Food Manager/Level 2 Course which requires an exam.

What is the format / what happens during the class?

- The course material is in slide format with an instructor present
- There are 5 sections:
 - Foodborne Illness/Food Cycle/Human Factors/Environment/Regulations & Procedures
- You must stay on camera during the entire course and answer questions verbally after each section

So there is no exam?

- Correct, there is no exam for this course.
- However you are required to attend the entire course and answer questions during and after each section.

How can I register?

I have a group. Can I register more than 1 person at a time?

- Yes. Contact me. I'll need a list of names and emails of attendees.

What is the fee?

- Fee is \$30/person for the regularly prescheduled times
- Fee is \$60 for a custom time slot. Contact maryangela@keepsafefood.com to arrange.
